The Izaak Walton League - Wildlife Achievement Chapter Inc., appreciates the vendors that participate in their Damascus Wildlife Rangers, SASS Md. State Championship of Cowboy Action Shooting. We feel the vendors are an integral part of the success and overall atmosphere for the shooters. We also understand the cost associated with your business. Therefore, we do not charge for vendor spaces. In the past, vendors were given spaces on their word that they would be there. Unfortunately, some have taken advantage of this policy and, without notice, failed to show up. Our vendor area has limited space. Only a limited number of vendors can be accommodated. We will only accept limited numbers of vendors selling the same type of product. If we can have 16 vendors and 8 of them are selling clothing, everyone loses.

Because several vendors, in the past, had nothing to lose by not showing, we may request a \$100 deposit for a vendor space. This is refundable within two weeks after the completion of the event. We do have camp sites available but they do not have any hook ups. Our posse system has each posse getting on a break each day of the match. This gives shooters ample time to shop. Our match has a shooter cap of 156 shooters and we also have a conventioner entry on side match day. Vendor spaces are on a firstcome first serve basis. Your completed application, along with the funds when required, reserves the space. Any cancellation after May 31, 2010 may cause a forfeit of the deposit. The Izaak Walton League, the Damascus Wildlife Rangers and the Wildlife Achievement Chapter are not responsible for lost products or damage. Vendors are responsible for their own insurance and reporting of sales tax. Vendors do not get free shoots but, you do get a free Friday evening BBQ. We reserve the right to refuse any application. Match dates are June 24, 25 & 26, 2010.
