Join us as our Cowboy Action Shooters challenge our local Law Enforcement Officers & First Responders to a friendly competition to see who is the Top Gun. LEO's & FR's can use firearms typical of their profession, a pistol or revolver, service type rifle (**no steel core ammo**), and a service shotgun. No race or modified "competition" firearms. Cowboys will use their single action revolvers, side by side or pump shotgun, and a lever action rifle; all cowboy guns must meet SASS (Single Action Shooting Society) regulations. Cowboy dress is required by all Cowboys and some form of police, swat, Fire Department or correctional officer clothing is required for LEO's & FR.

The match will consist of 6 courses of fire, three will be police oriented and three will have a cowboy theme. The mandatory safety talk is at 9:45 AM, the match begins at 10:00 AM. Match location is the Wildlife Achievement Chapter of the Izaak Walton League of America, 26430 Mullinix Mill Rd, Mount Airy, MD, 21771.

Please report to the rear entrance to the Chapter House to sign-in and pick up your shooters badge.

The match fee is \$25 and includes a prepared lunch and shooters badge. A plaque will be awarded to the Top Cop and the Top Cowboy of the match. All entry fees will be donated to an organization that supports widows and children of police officers and firefighters that have fallen in the line of duty.

The sport of Cowboy Action Shooting consists of shooting targets, many of which are steel, with live ammunition. Participation in this sport is done **with the knowledge that shooting firearms is inherently dangerous and it is impossible to guarantee, completely, that occasional lead splatter will not enter the shooting and spectator area.** Every precaution is taken to make this sport safe; however, we cannot be responsible for injuries or property damage caused during shooting matches. All participants and observers must wear hearing and eye protection while in the shooting area. The WAC-IWLA is not responsible for personal injuries, damage to vehicles, equipment, firearms or clothing. **Unsafe behavior, improper use of firearms, failure to obey safety instructions, use of alcohol or drugs (illegal or performance hampering prescription), or failure to respond to any safety command will result in an immediate call of cease fire until the situation is rectified.**

Signing this registration indicates that you understand, and agree with, the aforementioned conditions of the match and that you knowingly forfeit the right to hold the WAC-IWLA, its officers, workers, and/or match personnel liable for injuries or damages caused while participating in shooting events. This also includes the actions of 3rd parties.
