We will cover the history of Cowboy Action Shooting, the clothing, firearms, ammunition, rules, safety, what to expect at a match and how a match is run. If have experience with the firearms, you will shoot an actual cowboy scenario at the end of the class. We will provide all firearms and ammunition if you do not have your own. Please bring ear and eye protection. For additional information see our web site or contact Chuckaroo on 301-831-9666.

This course is not meant to be initial firearms training. It is designed for shooters that are familiar with shooting (unassisted) pistols, rifles and shotguns. If you are NOT experienced with the use of these guns, you cannot take part in the live fire portion but you may observe the other shooters. **I HAVE EXPERIENCE WITH THESE FIREARMS CHECK ONE YES NO**

The class will last approximately 4 1/2 hours. The class will begin at the main club house of the Wildlife Achievement Chapter of the Izaak Walton League of America, 26430 Mullinix mill Rd., Mt. Airy, Md. 21771. Directions are on the web site. We will start the classes promptly at 9:00 AM. All students will receive a confirmation by E-mail. You do not have to be in cowboy clothing or be a SASS member. Cost is \$5.00 per person, inclusive.

The sport of Cowboy Action Shooting consists of shooting targets, many of which are steel, with live, all lead, ammunition. **All ammunition must be loaded to SASS (Single Action Shooting Society specifications)** for the safety of participants and spectators. Participation in this sport is done so *with the knowledge that shooting firearms is inherently dangerous and it is impossible to guarantee, completely, that occasional lead splatter will not enter the shooting and spectator area.* Every precaution is taken by the Izaak Walton League of America, Wildlife Achievement Chapter Club Inc., to make this a safe sport however, we cannot be responsible for injuries or property damage caused during shooting matches.

All participants and observers must bring and wear hearing and eye protection during the class while there is gunfire. The club is not responsible for personal injuries, damage to vehicles, equipment, firearms or clothing. **Unsafe behavior, improper use of firearms, failure to obey safety instructions, use of alcohol or drugs (illegal or performance hampering prescription), or failure to respond to any safety command will result in an immediate call of cease fire until the situation is rectified.**

Signing this registration indicates that you agree with the above conditions of the match/training and that you knowingly forfeit the right to hold the Izaak Walton League of America, Wildlife Achievement Club Chapter Inc., its officers, workers, Atlantic Guns Inc. and/or match personnel liable for injuries or damages caused while participating in shooting events.
