TO BE VOTED ON

Because of increasing costs of everything necessary for the operation and maintenance of your club house and grounds, it has been pointed out that increased revenues are necessary. To produce the needed funds, in addition to holding our annual Bar-B-Que and Oyster Roast (this year), we have a potential in the rental of our club house and grounds to outside clubs and organizations, as well as industrial employees associations. In the past the house and grounds have been rented on a limited basis of not more than two Saturdays in any one month during the Spring and Summer months. It is proposed that we make the house and grounds available for rental on all Saturdays until 6:30 P.M. during the months of May through September. Also that we not make the club house and grounds available for outside rental on any Sunday during the same period. This proposal was

announced at our February Membership Meeting and will be voted on at the Membership Meeting in March. A survey taken on Saturday afternoons during the past Summer indicate that this will not impose a penalty on our membership. If you feel that such a move is objectionable, come to the March Membership Meeting and let your objections be heard.
