SKEET SHOOT FOR WALTONIANS & FAMILIES

The Silver Spring Chapter of the Izaak Walton League of America is planning to hold a series of skeet shoots this summer in conjunction with the National Skeet Shooters Association. The first of these shoots will be "The Spring Invitational". Invitations are cordially extended to all Izaak Walton League of America members and their families. The shoot has been designed for young and old, novice and hot shot, so that all will have an equal chance of winning one of the beautiful trophies that will be given away as awards. There will be six classes in which a shooter may be placed according to his or her shooting ability. This will all be determined by the scores at the shoot. In each of the six classes there will be first, second and third place trophies awarded. On top of the trophies awarded for personal performance, there will be additional trophies: one for the outstanding lady shooter; one for the outstanding junior class shooter (this is a boy or girl who has not reached their 17th birthday); one for the sub-junior class shooter (any boy or girl who has not reached their 13th birthday).

Now for you shooters that like real hot competition there is the two man team competition. This can be entered by any two shooters, young or old, man or woman. Trophies will be awarded to the first and second place teams in this class with both shooters of both teams receiving trophies. Many very beautiful trophies have been obtained for this shoot and they may be seen on display at the clubhouse. This exciting shoot will be held on the club skeet range on Sunday, May 28, 1967. Shooting will start promptly at 9:00 A.M. It is highly recommended that shooting times be reserved in advance to assure yourself a chance to shoot. All shooting will be done with 12 gauge shotguns altho a shooter may, if he wishes to handicap himself, use a smaller gauge gun. New and reloaded ammunition will be available at the clubhouse. The shooting will consist of 100 targets--the fee for this will be \$9.75 per person. For those of you who do not belong to the National Skeet Shooters Association, there will be a \$1.25 temporary membership fee. For those of you who wish to compete in the ladies, junior or sub-junior classes, there will be an additional \$3.00 fee. Shooters wishing to shoot as a two man team will have an additional fee of \$2.00 per man. The trophies will be awarded at the end of the shoot. Winners may have their names engraved on their trophies if they wish. The trophies will range in size from 8" high to a towering 21" in height. During the entire shoot refreshments, such as Bar-B-Que, hot dogs & hamburgers will be served at the clubhouse.
