### GUN CONTROL BILL

On July 2nd the Montgomery County Council met to discuss and introduce proposed amendments to the Weapons Ordinance Chapter Code 109, Montgomery County Code 1965. Its purpose is to establish a system of Firearm Owners Registration.

(There will be further public hearings during the first week in September 1968.)

A gun owner will be required to register each weapon he owns. State under oath to certain statements and then your application will be reviewed by the County Police Superintendent and if he considers that you have made a fraudulent or false statement you will then be required to turn in your weapon within 48 hours. It hints upon the right of search and seizure by the police department. It further prohibits the ownership of, or custody of, switchblade knife, blackjack, slingshot, sandbag, metal knuckles, or a silencer device.

The cost (presently proposed) will be one dollar. We all know what happened to Topsy. This one dollar cost is supposed to be good for a 5-year term.
