AN AMENDMENT REGARDING DISBURSEMENT of club funds was submitted in writing at the last membership meeting. At present, only the Treasurer is permitted to write checks. When the Treasurer is out-of-town or unable to attend a Board meeting, appropriate disbursements are held up which may cause us credit problems. The amendment will permit the President to sign checks in the absence of the Treasurer. The proposed amendment will read as follows and will need membership approval at the January meeting:

Article XI Section 2

All disbursement of funds shall be by check signed by the Treasurer, or by President in the absence of the Treasurer.

NEW REGULATIONS FOR THE TRAP AND SKEET RANGES will become effective February 1, 1975. The Board of Directors approved the following:

- (1) The ranges will be closed to the public except on special days.
- (2) Guests accompanied by members may fire on the ranges at two occasions only unless the guest is from outside the membership area. If a guest desires to continue shooting, he should submit an application for membership.

- (3) A written record of members and guests shooting on the ranges will be maintained in the range registration house.
- (4) In an effort to cut costs, no more than one person will be employed to operate the range equipment. Members are asked to help by receiving registrations, loading machines, pulling birds and scoring the rounds.
- (5) A range qualified chapter member must be present at all times while the ranges are operating.
