CONSERVATION FLASH - Our Chesapeake Bay problems are finally getting statewide and national attention. After many years of diminishing seafood production and increased pollution from water traffic, waste treatment facilities and runoff from farms and city streets, our government agencies are beginning to awaken to the cry of the Izaak Walton League and other conservation organizations. The League is spearheading a drive for public awareness of Chesapeake Bay problems and demanding a cleanup based on research data. To restore the Bay to its bountiful and beautiful state will take millions of dollars. Governor Hughes is asking for 40 million in our Maryland budget, Governor Robb of Virginia is requesting 10 million for the lower bay and President Reagan is budgeting 10 million - all of this is just a beginning to the massive needs in the Chesapeake Bay region. Bill Roulette of the Talbot County Chapter, IWLA, is Chairman of the Chesapeake Bay Committee for the Maryland Division of the League. He will bring his knowledge of the Bay to our March 28 Dinner Meeting and explore ways we can help restore the Bay's life. Put the 28th on your calendar, come to dinner at 7:15 and Bill will speak at 8:00 PM. The public is invited - bring your friends.

Charles Wiles Corresponding Secretary, 972-1953 PROPOSED AMENDMENTS TO THE BY-LAWS OF THE WILDLIFE ACHIEVEMENT CLUB CHAPTER, IWLA

ARTICLE I, SEC. 9: AMEND TO READ 'CHILDREN OF MEMBERS', RATHER THAN 'SONS OF MEMBERS'.

REASON: THIS IS PROPOSED TO MAKE THIS ARTICLE CONSISTANT WITH THE WORDING OF OTHER BY-LAWS.

ELIMINATE THE PHRASE 'SONS OF WIDOWED OR DIVORCED MEMBERS OF THE SLIGO CHAPTER IN GOOD STANDING AND MEMBERS OF THE MONTGOMERY BLAIR CHAPTER IN GOOD STANDING'.

REASON: THESE TWO CHAPTERS ARE NO LONGER IN EXISTENCE.

ELIMINATE ALL QUOTATION MARKS IN THE ARTICLE. REASON: THERE ARE NO QUOTATIONS IN THE ARTICLE.

ART. II, SEC. 10: AMEND TO INCLUDE THE PAYMENT OF STATE DUES AS A CONDITION OF GOOD STANDING OF A CHAPTER LIFE MEMBERSHIP.

REASON: THIS IS TO BRING THE CHAPTER BY-LAWS IN LINE WITH THE STATE ORGANIZATION.

ART. III, SEC. 1A: ELIMINATE THIS ENTIRE SECTION.
REASON: THIS SECTION NO LONGER SERVES ANY PURPOSE.

ART. IV, SEC. 4: AMEND TO READ '... INVOLVING THE EXPENDITURE OF THREE HUNDRED (\$300) DOLLARS ...'.
REASON: INFLATION DICTATES THAT IT IS NO LONGER PRACTICAL TO WORK WITH THE \$100 FIGURE.

ART. V: INCLUDE THE DUTIES OF THE CHAPTER PARLIAMENTARIAN.

INCLUDE THE DUTIES OF THE CHAPTER CHAPLAIN.

REASON: THESE OFFICES ARE NOT CURRENTLY DEFINED IN THE BY-LAWS.

ART. VII, SEC. 3: AMEND THE THIRD SENTANCE TO READ '... ALL FUNDS RECEIVED AND DISBURSED BY IT.'

REASON: THE BY-LAWS PRESENTLY DO NOT MANDATE A COMMITTEE TO MAKE A REPORT OF FUNDS WHICH IT HAS SPENT.

SEC. 6: AMEND TO REFLECT THE CURRENT COMMITTEE STRUCTURE
OF THE CHAPTER.

REASON: SEVERAL STANDING COMMITTEES WHICH ARE CALLED FOR IN THE BY-LAWS HAVE NOT BEEN IN EXISTENCE FOR SOME TIME.

SEC. 7: AMEND TO ELIMINATE SUB SECTIONS D, E, &M.

REASON: THE ELIMINATION OF THESE COMMITTEES IS TO BETTER REFLECT THE CURRENT COMMITTEE STRUCTURE OF THE CHAPTER.

AMEND TO COMBINE SUB SECTIONS H & I.

REASON: TO ELIMINATE OVERLAP IN THE RESPONSIBILITIES OF THE HOUSE COMMITTEE AND THE GROUNDS COMMITTEE.

AMEND SUB SEC. J TO INCLUDE SKEET

THERE WAS NO MENTION IN THE BY-LAWS AS T

REASON: THERE WAS NO MENTION IN THE BY-LAWS AS TO THE MAINTANENCE OF THE SKEET FIELDS AND TRAPS.

AMEND TO SEPERATE SUB SEC. K INTO TWO NEW SUB SECTIONS REASON: SEPERATING THE RIFLE AND PISTOL COMMITTEE INTO TWO

INDIVIDUAL COMMITTEES WILL ALLOW BETTER MAINTANENCE OF THE RANGES.

AMEND TO CREATE A NEW SUB SECTION WHICH DEFINES THE RESPONSIBILITIES OF THE SAVE OUR STREAMS COMMITTEE. REASON: THIS COMMITTEE IS CURRENTLY NOT DEFINED IN THE

ART. 7, SEC. SUB. SEC. A: INSERT INTO THIS SECTION AFTER THE FIRST SENTANCE, 'THE COMMITTEE SHALL BE RESPONSIBLE FOR THE PREPERATION OF AN ANNUAL BUDGET.'

REASON: THIS SHALL BE A MAJOR DUTY OF THE BUDGET/FINANCE COMMITTEE.

SEC. 7, SUB. C: INSERT THE PHRASE 'WILDLIFE MANAGEMENT AS WELL AS', AFTER THE PHRASE '... ALL PROJECTS HAVING TO DO WITH...'

REASON: AS THE WILDLIFE ACHIEVEMENT CLUB CHAPTER, THE CONSERVATION COMMITTEE SHOULD BE CHARGED WITH THE CONSERVATION OF WILDLIFE.

ART. XII: ADD THE TITLE | DISSOLUTION OF CORPORATION'
REASON: THE ARTICLE CURRENTLY HAS NO TITLE.

BY-LAWS.

ALL BY-LAWS: EXCEPT IN REFERENCE TO THE WILDLIFE
ACHIEVEMENT CLUB CHAPTER, ALL REFERENCES TO CLUB
OR CLUBHOUSE TO BE CHANGED TO CHAPTER OR CHAPTERHOUSE.

REASON: LEGALLY THE ORGANIZATION IS NOT A CLUB, THE BY-LAWS SHOULD REFLECT THE STATUS OF A CHAPTER OF THE IWLA.

ART. IV, SEC 4: AMEND FOURTH SENTENCE TO READ:

ALL APPROPRIATIONS OR OBLIGATIONS NOT APPROVED IN THE BUDGET INVOLVING THE EXPENDITURE OF \$300 OR MORE IN TOTAL SHOULD BE APPROVED BY THE MEMBERSHIP

REASON: BUDGETED OBLIGATIONS APPROVED BY THE MEMBERSHIP WILL NOT HAVE TO COME BACK A SECOND TIME FOR MEMBERSHIP APPROVAL.

ART. V, SEC 4: AMEND SECOND SENTENCE TO READ:
HE (CORRESPONDING SEC.) SHALL SEE THAT THE MONTHLY
BULLETIN AND NOTICES OF MEMBERSHIP

REASON: SPELLS OUT JOB ALREADY BEING PERFORMED BY CORRESPONDING SECRETARY.
