

HUNTER SAFETY COURSES BEGIN ON FRIDAY EVENING, 7:00 P.M., SEPTEMBER 7th.
"Mac" McCollum, Chairman of our HUNTERS SAFETY PROGRAM, announced that the first session
begins at 7:00 P.M. on Friday, September 7th; the second session continues on Friday,
September 14, at 7:00 P.M., and the third session will complete Course I on Saturday,
September 15, at 9:00 A.M. To receive credit for taking the course, all three sessions
must be attended. Maryland requires that all hunters applying for their first hunting
licenses in Maryland must show a certificate of completion of an approved Hunter Safety Course.
The course covers many safe hunting aspects including the use of shotgum, rifle and bow and
arrow. Range practice will be conducted at the last session. A \$1.00 charge is collected
to cover ammunition and course materials. This is an excellent course for parents to attend

DO WE WANT TO CLOSE OUR RIFLE AND PISTOL RANGES MONDAY THRU FRIDAY and open them on Saturday and Sunday only with Range Officers on duty?? This is one alternative to the improper use and wanton destruction of range standards, sand bags, signs and waste containers. We apparently have a few shooters in our chapter who neither abide by the written rules nor respect Chapter property. This is a request of all Chapter members to demand identification of Range users (ranges are closed to non-members unless a guest of a member present) and to report any and all misconduct on the Ranges to Wanda Dawson at the Chapter House, or call John Walter at 946-6001. ALL SHOOTERS MUST SIGN IN AND OUT AT THE CHAPTER HOUSE BEFORE USING THE RIFLE OR PISTOL RANGES.

ACID RAIN - A REPORT FROM GERMANY. We have described in past newsletters the need for controlling sulfur dioxide and nitrogen oxides, the air pollutants responsible for most of our acid rain. American Forests magazine recently revealed the serious decline of spruce and fir in the famous Black Forest of Germany as a result of increased acids in falling rain and fog. Approximately 3/4 of all fir trees in the area are suffering from the effects of acid rains. With the decline of many Canadian and American forests and lakes, and now those being reported in overseas areas, we must get our Congressional leaders to take strong action for reducing smokestack emissions.

THE SENECA VALLEY RIFLE CLUB's high power tournament held July 28th was well received with 26 members participating. Congratulations to Fred Link who won the match. The tournament rank smoothly with everyone having a good time.

Although any high power rifle was allowed, all except one participant used a service rifle with the majority using Ml's. The next NRA approved tournament will be held September 15th and any high power rifle may be used. (no scopes) The club will provide Ml's and ammunition for those who want to fire service rifles.
