### SPORTSMAN TEAM CHALLENGE DEMO

### RAHN, FRIED NEXT OVERALL IN WAC JUNE SHOTGUN FETE

A special demonstration of the STC was given at our rifle range on June 24. Rick Fiore, Gary Montgomery and Greg Talamini set up the targets for the rifle portion of the event at the end of the Chapter's Military Rifle Shoot. In preparation of the two minute timed event, the trio loaded two ten round capacity clips for each of themselves. #### 1-2-3 Lewis Stats

#### 22 WIN PRIZES IN 1-2-3 SHOT

Only one straight was shot in the 128 rounds registered in the June 1-2-3 Shotgun Tournament. Overall Winner Bob Woodward got them all in his first round of skeet, getting off to a fast start on his way to winning the whole shooting match. There were a number of 24s - two each, in fact, by Woodward, by the always competitive Shotgun Programs VP, Chuck Crooks, and by the 1-2-3 Director, John Dyer.

Snapshooting Bob Woodward, almost unchallenged, won the first WAC 1-2-3 nine-day shotgun tournament, breaking 140 of a possible 150 in the three-event competition that ended June 21. He finished 11 targets ahead of his nearest challenger, Bill Rahn, the Chapter's long-time shotgun sports mentor, who shot a 129. Veteran shooter Rick Fried was third overall with 125.

Twenty seven members and guests shot in the 1-2-3 competition. Twenty two of the competitors won Lewis Class prizes in skeet, trap, or 5-Stand (see article on details).

Woodward won a large Bob Allen Shooter's Carry Bag. For his second place finish, Bill Rahn was awarded a delux mesh Game Winner Sporting Vest. For third, Rick Fried won an Action Products Gun Care Caddy complete with built-in vice. In addition, the top three 1-2-3 winners received RealTree long-sleeve shooting shirts.

Added to the top prizes, Woodward won two cases of shells in the Lewis Class payoffs, finishing first in both Skeet and 5-Stand. Rahn won six boxes of shells for finishing in the money in Lewis classes in Skeet and 5-Stand. Fried won eight boxes of shells for his Lewis finishes.

(The complete 1-2-3 payoff is listed elsewhere in this issue and posted in the Range House. Winners must see Tournament Director John Dyer, or shotgun chairmen Bill Rahn or Chuck Crooks to collect).

#### "Marilyn" Was Hot

Woodward won with his much admired new Remington 11-87, called "Marilyn Monroe" by some for its ashe blond good looks, accented by a curvy figure.

## To Each His Own

## Look Back, Look Ahead

With the glamorous "Marilyn" well in hand, he made a good case for light loads, winning both the skeet (72x75) and 5-stand (46x50) games on his way to the top. His handloaded 12-gauge Federal shells were packed lightly with 18.5 grains of Red Dot under #9 hard shot in all three events. He finished fifth in trap (22x25) behind winner Steve Kane's sparkling 24x25 but that was enough to add up to first prize overall for Bob and "Marilyn".

## On Time, On Target

Throughout the nine June days designated for the 1-2-3 shoot - the first three Wednesdays and weekends - the weather held clear although often hot. The contestants shot a total of 128 rounds without a washout, or heat stroke. Main reason: The Range Officer/Referees on duty moved the competition without a hitch, scoring the competitors promptly and accurately under the watchful eye of Chief Judge John Corbin. In addition to establishing the rules for the competition, Corbin on his own initiative, took over running the more complicated 5-stand game during many of the shooting hours.

Specially responsive was Marc Grimes, who scored 27 rounds, most of them when tournament director John Dyer showed up with five members of his family to shoot on the fiery afternoon of the tenth! Dyer scored 20 of the 1-2-3 rounds and Cornell Kittel, Ed Bennett and Bob Woodward led a dozen other Range Officers/Referees in counting and certifying contests' hits and misses and handling the extra 1-2-3 accounting chores at the Range House, ably abetted by shotgun business boss Chuck Crooks.

The Cherney brothers, members Fred and Berle, made special, highly professional contributions to the success of the 1-2-3 Tournament. In his Bethesda print shop, Fred helped John Dyer prepare and reproduce - at no cost to WAC - all the 1-2-3 literature...posters, score and accounting logs, information mailings, rules brochures, memos to the range officers, and the text and illustrations for the NEWSLETTER inserts, including this one. Berle Cherney, a full-time professional photographer, covered the 1-2-3 action on the fields (see photos) snapping the contestants in and out of action. Archie Cheng shot the descriptive cover photo of Bob Woodward.

The shooting style and tempo of the top three 1-2-3 shooters varied greatly. Woodward's quick, low-gun attack (see photo), calling "pull" almost as soon as he toes the pad, amounts almost to hip-shooting, and relies on his remarkable reflexes to overcome any vagaries in target trajectories or weather conditions. Bill Rahn, in contrast, has adapted the precise close-footed stance, careful set-up and reflexive leading taught him at the Orvis shooting school he attended earlier this year. Rahn shot the skeet and 5-stand part of the 1-2-3 course with his high-grade Winchester 101 12-gauge skeet gun and the trap part with his Winchester 101 single-barreled trap gun. He supplemented his regular skeet handload (all Winchester components around 20.5 grains of WW 452), with factory WW Super Handicap loads, some with #7 1/2 and #8 shot for long shots and rabbits.

Left-handed Rick Fried varies his form by game to accommodate his portside view of the targets. Generally, he favors the "pass through" method, swinging through the bird, firing just as he sees it over the sights. His strong 23x25 in trap, using a Benelli SP 80, made him runner-up in that competition. He shot his old Ruger Red Label for the other two events. Amazingly, Fried's 5-Stand round (38x50) was the first he ever shot on that field! And, until a couple of weeks before the 1-2-3 Tournament, he hadn't shot skeet actively since 1987...but he broke a respectable 64 of 75!

## The Machinery Genie Smiled

All the traps purred and performed throughout the tournament. That's because they were sweet-talked and stroked for a couple of weeks before the 1-2-3 shooting started by Bill Rahn, Ed Bennett, John Corbin, Jim Malone and a SWAT team of WAC technical experts. Chapter resident Cecil Hensley policed the ranges and loaded the trap houses with fresh cartons of targets so that all was ready at the tournament start.

The new Super Star launchers installed recently in Skeet Field #3 withheld their priorly electronic peculiarities and slung their birds fast and far throughout the official 1-2-3 shooting times. The rebuilt trap machine on Field #2 operated flawlessly. The six 5-stand machines, including the often reluctant rabbit, put 'em up when called out.

Director Dyer, and others involved in the shotgun program, were disappointed in the turnout of 27 contestants out of a club membership of well over 800, despite the advance publicity, flexible scheduling, good weather and inviting prizes. However, the receipts from entry fees, practice rounds and tournament-related ammunition sales put the event just into the black as was the goal.

A quick post-shoot verbal survey uncovered no common objections to the 1-2-3 format... rather, those sampled, and many others who volunteered comment, were consistently positive. Lee Slavin said "That was really fun! Do it again right away!"

A longer look will be taken in time, Dyer said, querying all active shooters. The next tournament will be under the direction of incoming shotgun leader, Ed Bennett.

## BOWHUNTING - Tree Stand Safety by John Walter.

Hunting from a tree stand is very popular and productive way to "bag your buck". It's also a good way to get seriously injured or worse. So while you're busy getting the rest of your gear ready, check your stand for safe conditions. Make sure all bolts, lock washers, nuts, chains, etc. are in good shape.

As a Maryland Hunter Safety Instructor, I receive a copy of the Hunting Accident Report each year. One fact that holds true each season - over 40 percent of these accidents are tree stand related. Out of 23 reported accidents this past year in Maryland, ten involved tree stands. One in Washington County was fatal. Falling out of a tree is not funny, as any of these victims can attest to. Most of these incidents could have been prevented by some simple maintenance and the common sense to use a safety belt or harness.

Have a safe and successful hunting season and don't become a statistic. Check your stand to be sure it's in top shape and use your safety strap at all times.

I'd also like to thank the people who have contact me (or tried to) with information on excelsior bales. Dr. Charles Wiles, Past Chapter and National IWLA President contacted me. He has a supply of them that we can purchase at a good price. Thank you Dr. Wiles.

# PROPOSED CONSTITUTION CHANGES

The Committee on Constitution and By-Laws met June 7, 1995 to readdress the non-participation of our general membership in facilitating work details and fund raisers necessary in the overall good and well being of our Chapter. The Committee recommends the following changes in our Constitution. These proposed changes will be listed in the July/August issue of the NewsLetter and will be voted on by the general membership at the Chapter's General Membership Meeting on August 23, 1995.

**Please note that these changes are different from the changes mentioned in the June/July NewsLetter.**

*(Note: New wording is presented in italics and highlighted).*

## 1. Article III Section 2

**Old Reading:** Every application for membership shall be endorsed by at least one member of the Chapter and shall be accompanied by the required initiation fee and current dues, and the proposed applicant must be present personally at one function of this organization prior to being voted upon.

**Change:** Every application for membership shall be endorsed by at least one member *in good standing* of the Chapter and shall be accompanied by the required initiation fee and current dues, and the proposed applicant must be present personally at one *Board of Directors Meeting* of this organization prior to being voted upon.

## 2. Article III Section 5

**Old Reading:** Each member who has been elected to membership in the Chapter, shall undergo one (1) years probation as a member, this probation period to terminate one (1) year from the date he/she was elected to membership. During this probationary period the member may be expelled by a two-thirds vote of the Board of Directors present at a regularly scheduled meeting. All dues and initiation fees will be returned upon his/her expulsion under this section.

**Change:** Each member who has been elected to Membership in the Chapter, shall undergo one (1) years probation as a Member, this probation period to terminate one (1) year from the date which he/she is elected to membership. *During this probationary period all new members will be required to work on a minimum of two (2) Chapter events. Events can be fund raisers or committee functions requiring a work detail as sponsored by the Board of Directors. New Members failing to meet this requirement will be ineligible for membership renewal for one (1) year, after which they can reapply as a new member.* During this probationary period the member may be expelled by a two-thirds vote of the Board of Directors present at a regularly scheduled meeting. *All unused dues will be returned upon his/her expulsion under this section.*

## 3. Article IV - Board of Directors

**Old Reading:** The government of the Chapter, the direction and supervision of its work, and the management of its financial and business affairs shall be vested in the Board of Directors, constituting of the officers of the Chapter and seven other members, to be elected at the annual meeting, for a term of one year.

**Change:** The government of the Chapter, the direction and supervision of its work, and the management of its financial and business affairs shall be vested in the Board of Directors, constituting of the officers of the Chapter and seven other members, to be elected at the annual meeting.

*(Note: Article IV is being changed because the wording of the Constitution conflicts with the By-Laws which state that the Board of Directors is elected for a period of two years, not one year, as stated in the Constitution. The only change from the original is elimination of the last six (6) words).*

## MARYLAND DIVISION CONVENTION

Our Wildlife Achievement Club Chapter hosted the Maryland State Division Meeting Saturday June 17 at the National IWLA Center. Following the meeting, the Awards Banquet was held at our Chapter house. The Lewis System of prize distribution worked remarkably well in this tournament, it's first try at WAC with wide spectrum of shooter skills. In the final Lewis payout, 22 of the 27 entrants shared 34 Lewis awards, ranging from a full case of shells for outright class winners to boxes and parts of boxes of shells for those lower down and ties.

Four Lewis classes of seven shooters each were set to cover the 27 who shot skeet. The Skeet Lewis winners were: Woodward, Crooks, Dyer, Berle Cherney, Cheng, Fried, Tom Ouellette, Rahn, Kane, John Dyer III, Grimes, Merollini, Wright, Slavin, Hancock, Lohm and Wood.

Three Lewis classes of seven were set for the 20 Trap contestants. Lewis winners in Trap were: Kane, Fried, Humphries, Myers, Buckinham, Hancock, John Dyer III, McArdle and Tom Ouellette.

Only two Lewis cuts could be made for the 14 who competed in 5-Stand. Winners here were: Woodward, Rahn, Fried, Sterling, Merollini, Dyer (pere), Tom Ouellette and Humphries.

Lewis winners must see John Dyer, Bill Rahn or Chuck Crooks to collect their awards. At this writing many are uncollected. Bill Rahn cautioned, "Lewis winners better pick up their shells right away!! The selection in the Range House is getting thinner every day and it's getting harder and harder to stock everything we'd like to have."

In a late breaking decision, the tournament and club officials have decided to allow all 1-2-3 shooters who paid for, but did not complete their tournament rounds, to shoot them out without further expense. To do this, unfinished 1-2-3 shooters must secure written authorization before shooting from Rahn, Dyer or Crooks, which can then be turned in to duty ragne officers as a credit when shot out.
