PROPOSED AMENDMENTS TO THE BYLAWS

The IWLA -WAC Board of Directors has accepted and approved three amendments to our Chapter's Bylaws. Before these amendments can take effect, they must be approved by a two thirds vote of the membership, at our March 22nd, 2006 membership meeting.

Article III - Membership

Section 5

Current Reading;

All members who have been elected to membership in the chapter shall undergo one year probation, this probation period to terminate one year from the date which they were elected to membership. During this probationary period, all new members will be required to work on a minimum of two Chapter events. Events can be fundraisers or committee functions requiring a work detail as sponsored by the Board of Directors. New members failing to meet this requirement will be ineligible for membership renewal for one year, after which application can be made as a new member. During this probationary period, the member may be expelled by a two-thirds vote of the Board of Directors present at a regularly scheduled meeting. Upon expulsion under this section, all unused dues will be returned.

Proposed Amendment

Article III - Membership

Section 5

All newly elected members shall undergo a probationary period, no more than three years in length. The probationary period is determined by the Board of Directors, and will be provided in writing to new members prior to their being presented to the BOD for consideration. During this period, all probationary members will be required to participate in Chapter activities. Activities may include, but are not limited to: Chapter maintenance days, event fundraisers, committee projects, conservation projects or Chapter Social events.

New members failing to meet this requirement will be ineligible for membership renewal for one year, after which, application can be submitted as a new member. During the probationary period, the member may be expelled by a two-thirds vote of the Board of Directors present at a regularly scheduled meeting. Upon expulsion, under this section, all unused dues will be refunded. Current probationary requirements will be listed on the membership application in use at the time. For applicants with special needs, a written request for an exemption can be filed with the Board of Directors for consideration.

Article V - Duties of Officers

Article XV - Amendments

These Bylaws may be amended or repealed, or new Bylaws may be adopted, by two-thirds vote of the members in good standing, present and voting at a meeting of the Chapter provided that the proposed amendment has been submitted in writing at a prior meeting, and that notice of the proposed change, and the date at which the proposed change is to be voted on, shall be mailed by the Corresponding Secretary to each member, not less than thirty days prior to the date of the meeting at which the action thereon shall be taken.

RIFLE AND PISTOL RANGE REPORT

Shooting Hours: Permitted rifle and pistol range shooting hours are posted on the box, which contains the range sign-in register, as well as above the range entry card reader. For January 2006, starting time is 10:00 AM daily and ending time is 5:00 PM, unless some activity has preempted the range.

Range Road: Again, remember that when we get snow, sleet, or freezing rain, the lower range road will become very slippery. Even though the upper range road may look fine, (it gets some winter sun) the lower road may still be frozen, at its steepest part. Use the range road at your own risk! If it gets particularly nasty we will close the road and post a notice of closure.

1Police Your Brass: In researching historical Rifle and Pistol Range articles, I noticed that the subject of "Policing your Brass" has occurred once in the last three years under the heading of, "Your Mother Doesn't Live Here." It could just as easily be, "Your Wife, Your Girlfriend," - whatever. The point is that some are getting lax in their responsibility to pick up after themselves. I have noticed that this tendency seems to occur more as the weather has gotten colder. I am also not referring to the brass that disappears into the snow, only to reappear during the melt. I am referring to brass under the roof and behind the firing line. Have a little pride in our range. Police your brass and place the steel casings in the trash and the brass casings in the small white buckets placed there for that purpose. Shotgun casings are the easiest to pick up and lately, have been the most obvious objects of litter on the rifle range. Take it one step farther. If you notice that pieces of carpet, shooting blocks, or sandbags are on the ground - pick them up, put them on a bench, and in the case of the carpet, put a sandbag or shooting block on top so the wind won't move it again.

At a private golf course, it is not unusual to see a sign pleading with members to repair their own ball marks on the green and another ball mark as well. I make a similar plea here. After you police your own brass, look to pick up other obvious brass on the ground. The results may surprise you, a range maintained in a state that members and their guests really enjoy and can be proud of.

Rifle Range Insulation Repair Project: On our December 18th range maintenance day, the majority of insulation under the Rifle Range roof was augmented or replaced. Additionally, the insulation was sealed in with chicken wire

and clipped together with hog rings to prevent rapid removal by the local squirrel posse. I've come across the little varmints running into the woods with insulation pieces bigger than they are clutched in their teeth. In the two days after maintenance day, while finishing up, I even had to evict a squirrel that had taken up residence in the front insulation above shooting station two. Boy was he ticked! My thanks to Ray Shaver, Alan Pressman, Sean Cooley, Rick Rollyson, Roman Drews, and Tim Urban for their stellar work.

FLY FISHING FORUM

Many of us prefer softer, slower rods while many prefer the faster, stiffer rods. My personal preference for the slower variety stems, I believe, from my wife teaching me the art of fly fishing. Not wanting to use a "good" rod on a beginner like myself, she pulled out an old fiberglass rod that was verrrry slow. That is what I got used to and what I prefer today. You may have a favorite rod (or five or ten) that is too slow/fast for your taste. Try stepping up/down on your line size. If you have a six weight that is just too fast, try putting on a seven weight line. Or conversely, you could speed up that slow six weight rod by putting on a five weight line. These changes can also help you adjust to differing conditions, such as too much wind, or a presentation that is just too hard. I also recommend regular line and rod cleaning. For a quick clean, I use a line cleaner and small rag (easy kits are readily available), but every so often, I will wash my line in the sink with warm water and mild detergent before drying and reconditioning. If you have not cleaned your line lately, try it. It will make a huge difference. Candice and I will be trying to put together something for the club in the next two months.

RANGE ACCESS CARDS for 2006

Please remember that your membership card is NOT what you will need to use the ranges in 2006. It is a separate card for you and/or a Range Approved spouse that will come in the envelope behind your membership card. It has an eagle in front of a flag for easy identification across shooting positions. It is already laminated with a slot for a clip punched in it. **IT MUST BE VISIBLY WORN WHEN USING THE RANGES.** Use the same electronic card that you already have to open the gate. It will continue to function as long as your dues are up to date. Clips for the cards are available at the Range House or during General Membership Meetings. Stop by and pick one up.

WINTER RANGE ROAD

Buckets of ice melt and gravel have been placed at the top of the range road to be used if people have problems exiting the range because of ice buildup on the new concrete pad.

MEMBERSHIP RENEWALS for 2006

For those who have NOT sent in a renewal payment for 2006, your membership "officially" expired on 12/31/05. A second and final bill should arrive the second week of January. If I have received your payment by January 31st, your membership will continue without penalty, but it will still take a few weeks for you to receive your new membership and Range Access Card. If I have not received your renewal payment by then, this is what

happens on February 1st:

- a. You will owe an additional \$40.00 to renew your membership
- b. You will not be allowed to use ANY shooting range or purchase reloading supplies until you renew
- c. Your electronic key card will be deactivated until you renew
- d. As of April 1st your membership will be terminated and you will have to re-join as a new member
