# NEW COWBOY SHOOTER CLINIC (Chuckaroo)

The next clinic will be held on Saturday, March 6, 2010 and the last clinic will be on Saturday October 30, 2010. Class sizes are limited, and seats are on a first come, first serve basis.

The purpose of the clinics is to introduce the sport to potential enthusiasts who'd like to give it a try without "the whole world watching." Though playing the game under the watchful eye of the Range Officer and their timer is part of the fun, that can be a little intimidating if you're new at it. SAFETY and fun are the real focus of the sport, and we'd like to be sure everyone gets off to the right start. Students will learn how the game is played, hear the SASS rules, see the equipment and accessories that are required, and get a chance to try out the range of firearms that are appropriate to the sport. A history of the sport is included in the classroom portion. Atlantic Guns and the Damascus Wildlife Rangers provide all equipment and ammo, if students do not have their own yet. Each person will get the chance to shoot a real cowboy scenario or two using the ol' hoglegs, scatter gun and lever action rifle! You will feel the fear of that dang buzzer and learn what real brain fade is like!

# The clinics are not meant to be initial firearms training. Students must <u>already</u> be familiar with the safe use and the loading of revolvers, rifles and shotguns.

## CMP Update ( Jean Aker)

Many Ikes are aware of, and have probably bought guns from, the Citizens Marksmanship Program (CMP). The CMP is the result of efforts by the U.S Government to promote citizen marksmanship and practice and safety in the use of firearms. They are also tasked with conducting competitions in the skilled use of firearms by awarding trophies, prizes, badges, and other insignia to competitors.

The CMP can trace its origins to 1903 and the efforts of Congress and President Teddy Roosevelt.

They established the **National Board for the Promotion of Rifle Practice** and the **National Matches**. From then until 1996 the Department of War and eventually the Department of the Army managed the program. In 1996 Congress enacted the **Corporation for the Promotion of Rifle Practice and Firearm Safety**. This is the current organization that governs the CMP.

Among its many programs the one that many are interested in is the sale of surplus firearms and ammo. Over the years the CMP has offered to the public, for a nominal fee, surplus weapons from the WWI 1903 bolt action rifle to the M1 series Garand and Carbine. Sales also include the 1917 US Enfield and several .22 caliber training rifles.

These weapons are offered for sale on the CMP website and require the purchaser to present adequate proof that they can purchase a weapon from CMP. The weapons for sale are graded according to their relative condition and are priced accordingly.

I have purchased an M1 Garand and two M1 carbines from CMP. My newest carbine was in a shipment of carbines that were returned to the US after years of service to the German police departments after WWII. They have been warehoused in Germany for many years and finally found their way back to the US. Among these carbines are some of the last ones offered for sale that were configured with the original flip rear sight found on early model carbines.

CMP recently announced that they have uncovered a large cache of M1C and M1D Garands and will be offering them for sale during 2010.

The M1C and M1D were sniper versions of the M1 Garand. The rifles are mechanically identical and the only differences are the M1D has a flash suppressor and the method of mounting the M82/M84 scope was different. The M1C scope was mounted on two rings and the M1D scope was mounted on a large single mount. CMP has not announced pricing as of yet, but I'll be there for one of my own.

# COMMITTEE REPORTS

## CONSERVATION (Meo Curtis)

What are the State of Montgomery County Streams?

The Montgomery County Department of Environmental Protection (DEP) is hosting public meetings to discuss the state of the county's streams. The public will be able to provide input on how the the County is meeting State regulatory requirements to: 1) achieve specific watershed restoration goals; 2) keep commitments to the Potomac Watershed Trash Free Treaty that calls for a trash-free Potomac River by 2013; 3) meet pollutant load allocations; and 4) encourage public input and participation throughout the process.

The Lower Monocacy, Potomac River tributaries (including Muddy and Watts Branch) and Seneca Creek watersheds will be the focus on Saturday, February 27 from 9 a.m. to 1 p.m. at Seneca Valley High School, 19401 Crystal Rock Drive, Germantown. The Anacostia, Cabin John, Patuxent, and Rock Creek watersheds will be the focus on Saturday, March 6 from 1 to 5 p.m. at Brookside Gardens, 1800 Glenallan Avenue, Wheaton.

Farm Fresh Organic Fruits and Veggies at the IWLA National Headquarters

Imagine being able to eat healthy organic garden fresh food this spring and summer without the worries of keeping your own garden! The folks at National will be partnering with a local farm (Calvert Farm) who will provide organic produce every week during the harvest season through a CSA (Community Supported Agriculture). The season begins May 23rd and runs through September 26th. There are usually 5-7 different fruits and vegetables in your share each week and variety depends on what is currently in season. A share in a CSA is a great way to have fresh, local fruits and veggies without all the hard work as well as support local farmers and the local economy.

The cost is \$20/week or approximately \$450 for the full season. Some people will split a share with a friend or neighbor if a full share might be too much. Pick-up is every Monday afternoon after 2pm at the IWLA Headquarters Office. Deposits and registration are due February 15th.

Plastic Bag Bill proposed in Maryland (again)

Plastic bags are among the most common of the litter items along our roadsides, in our streams, and in our trees and other vegetation. Many other countries and jurisdictions have come up with ways that reduce their use and inappropriate disposal, or at least help pay to clean them up after they escape into the natural environments.

Representative Al Carr of the 18th Maryland District plans to introduce legislation this session that would charge a nickel for each plastic or paper bag used by shoppers, similar to that recently enacted in the District of Columbia. At least 3 cents per bag would go to the Chesapeake and Atlantic Coastal Bays 2010 Trust Fund to pay for pollution mitigation. The Maryland law would provide a 1 cent rebate of the fee to the retailer for administrative costs, or 2 cents for retailers that offer rebate incentives to customers who bring reusable store bags. The rest of the fee would go toward Bay regional watershed preservation. There are exceptions to the bag fee in the legislation, including for hot carry-out food, meat, fresh produce and bulk items. Senator Jamie Raskin (District 20) will be introducing companion legislation in the Maryland Senate.

There are local and state laws about littering and fines for littering, but not much support for the staff and funding to enforce these laws. These means that we need to do something else to reduce the number of plastic bags flying by and floating downstream. #### **<u>RIFLE AND PISTOL COMMITTEE</u>** (Jesse Lim) **Range Safety Officer News:**

The range rules under the conduct section relative to range use for commercial training purposes, Rule# 21. <u>http://www.damascusiwla.org/RiflePistolRules.html</u>

No member may use our ranges for his or her commercial Training purposes. Using any WAC firearms range for financial gain, personal or otherwise, jeopardizes our charitable organization status and is a major conduct violation of our range rules. Anyone found to be in violation of this rule will have his or her range privileges suspended pending investigation by the Rifle and Pistol Range Safety Officer Committee, which will present its findings to the Board of Directors for their action.

Additional committee updates: In mid January, WAC Rifle and Pistol Range Safety Officers (R/P RSOs) were offered an opportunity to attend NRA basic instructor certification courses sponsored by our network colleagues at the Frederick IWL. Fifteen R/P RSOs attended and were certified in the basic pistol instructor discipline. Nine of those 15 were additionally certified with the basic rifle instructor discipline, as noted by an asterisk (\*). The objective is to use these new instructors to help expand the basic pistol and rifle training curriculum and offerings for WAC members.
