<u>Conservation</u> (Meo Curtis) Reddy Branch Buffer Maintenance—Saturday May 11th

We had a terrific turn-out of 19 members and 4 Americorps Interns for the Reddy Branch buffer maintenance near Brookeville, Montgomery County. This is another of our Chapter's long-term conservation projects, this one begun in 2009 with tree plantings on the MNCPPC parkland. The goal is to increase the forested buffer and wildlife habitat along this tributary to the Hawlings River which goes on to the Rocky Gorge Reservoir. Maintenance involves eliminating invasive vines like honeysuckle and oriental bittersweet and 'caging up' native tree seedlings. The caging is necessary to protect the young trees from deer browse and buck rub.


