# CHAPTER NEWS, EVENTS AND ARTICLES

#### Maryland Hunting Licenses (Greg Talamini)

For those of you who have held a MD hunting license, it's time to renew. Even if you don't think you can hunt this year, please buy a basic license. The money generated is needed by D N R for many funds, which help provide and protect our natural resources. If you are new to hunting, you can take the Hunter Safety Class here at WAC. Days and times are published on the web site. This course is required in order to apply for a license. It is time well spent along with access to our ranges, which provide a place to practice your shooting skills. For upland game and waterfowl hunters, you can practice your skill on the Skeet and Trap range. For deer hunters there are the rifle, pistol and archery ranges. Nationwide the number of hunters has fallen significantly in the past 35 years or so, according to the U.S. Fish and Wildlife Service. That means the natural resource officials must find new ways to control animal populations, especially deer. The office, which oversees all wildlife conservation programs, supervises animal population management and addresses nuisance complaints from residents, receives almost all its' funding from hunting and fishing license sales and federal matches. We need the support of hunters and all outdoors people. Officials blame the downturn in hunting on what some have called a "nature-deficit disorder." The average American lives farther from a forest than in the past and is often overburdened with work, school and organized activities for children. Children are not given the exposure to nature, the great outdoors, and all it can provide. We as Ike's should take on that responsibility by bringing our own children to our club, teach them how to enjoy nature and its benefits.

Buying a basic hunting license is the most passive way you can make a contribution if time is an issue.

#### **Upcoming Cowboy Clinic** (Chuck Crooks)

The next new cowboy shooter clinic, at Damascus, is Sunday, September 8, 2013. Class size is limited (20 shooting students), and seats are on a first come, first serve basis. **Pre-registration is required.**

The purpose of the clinics is to introduce the sport to potential enthusiasts who'd like to give it a try without "the whole world watching." Though playing the game under the watchful eye of the Range Officer and their timer is part of the fun, that can be a little intimidating if you're new at it. SAFETY and fun are the real focus of the sport, and we'd like to be sure everyone gets off to the right start. Students will learn how the game is played, hear the SASS rules, see the equipment and accessories that are required, and get a chance to try out the range of firearms that are appropriate to the sport. A history of the sport is included in the classroom portion. You can look at the Clinic Outline (<a href="http://damascusiwla.org/dwr/clinicoutline.html">http://damascusiwla.org/dwr/clinicoutline.html</a>) to see what's covered. Atlantic Guns and the Damascus Wildlife Rangers provide all equipment and ammo, if students do not have their own yet. Each person will get the chance to shoot a real cowboy scenario or two using the ol' hoglegs, scatter gun and lever

action rifle! You will feel the fear of that dang buzzer and learn what real brain fade is like!

The clinics are not meant to be initial firearms training. Students must <u>already</u> be familiar with the safe use and the loading of revolvers, rifles and shotguns. If you do not have experience, you can take the classroom portion but, you can only observe the live fire portion. For additional information contact <u>Chuckaroo</u> 301-831-9666.

#### Other News

For those members interested in learning more about water quality problems and pollution from non-point sources (NPS), EPA has some great on-line resources. Historically urban stormwater (runoff from developed areas) was considered a 'non-point source' because there was no one specific contributor to what was coming out of the storm drain system. Technically though urban stormwater is a 'point source' since the runoff comes into local streams and waterways out of pipes or channels constructed to drain development. All of the Maryland counties with 'urban' areas have been covered under these regulations since the early 1990's. Some large scale agricultural livestock operations are also regulated as 'point sources' of pollution but most agricultural activities are considered 'non-point sources' and not subject to stringent water quality regulations through the federal clean water act permit program.

Maryland is among a number of states with their own programs to reduce water quality impacts from agricultural operations and Maryland farmers have high rates of compliance. Important! It is your responsibility to read and understand our WAC R/P range's safety conduct and rules <a href="http://www.damascusiwla.org/RiflePistolRules.html">http://www.damascusiwla.org/RiflePistolRules.html</a>

Although members should read and understand **ALL** R/P rules, we would like to highlight a section under CONDUCT that we need to ensure all members are aware of:

18. No member may use our ranges for commercial training purposes. Using any WAC firearms range for financial gain, personal or otherwise, jeopardizes our charitable organization status and is a major conduct violation of our range rules. Anyone found to be in violation of this rule will have his or her range privileges suspended pending investigation by the Rifle and Pistol Range Safety Officer Committee, which will present its findings to the Board of Directors for their action.

If at any time you are approached by anyone at WAC for individual training for a fee on our rifle or pistol ranges, have any questions about the R/P rules, concerns about member conduct on the R/P ranges, do not hesitate to contact Jesse Lim.
