Chapter Awards (Jeff Deschamps)

There are a lot of good people in this Chapter and every year we ask for nominations for Chapter awards. It is sad when no nominations are forth-coming as we all know members that do something that makes this a better place. This year we do have two awards to present although I am sure there are others equally deserving. **Mash Esfanaji** – The first time I noticed Mash's activities I didn't even know who he was. I noticed because every month someone showed up on the Chapter Maintenance day with a car carrier. One or two pallets of birds were loaded onto the carrier and these were loaded from the carrier into the skeet houses. I assumed the person with the car carried used it I his job, but I could have been more wrong. Mash likes to collect tools and the car carrier is just one of those tools... Mary Esfanaji tells me he has quite a collection and I know our Chapter has benefited from this as he has also brought his arc welder out to the Chapter to repair some of the steel targets used in the cowboy shoots. If that was all Mash did you would say he actively supports his Chapter. At some point he began helping out with the beverage service. After working with Ken Lefebvre for a while Ken convinced him to take over. Now Mash is in charge of the beverage service. Mash always seems to be there if you need help and can also manage the work that needs to be done. We need more folks willing to manage Chapter activities, not just follow others and Mash has stepped up to do that. For these reasons **Mash Esfanaji** is receiving the **Chapter's Meritorious Service Award**.

David Goldberg – Dave has been involved with our Junior Air Rifle program for a number of years. He started as a coach and is now responsible for running the whole program coordinating all of the coaches and resolving conflicts on the club calendar. Junior Air Rifle is a program that meets three times a week from September through the end of the school year and then usually continues into early summer with a small number of our youths that have been invited to compete in national competitions. At our September membership meeting I learned that Dave also takes care of all the paperwork so that the other coaches can do what they do best coach our youngsters. During the past two or three years various people have talked about starting a junior archery program at our Chapter. Programs like this have been very successful at many other chapters. The problem had always been who was going to organize it – this is not something I could do. I can't recall if Dave volunteered or just didn't know how to say no when we talked about this project. Through his efforts all the people that were needed to accomplish this were brought together - this included our current archery chair, house and grounds, and most importantly the folks that had the knowledge to coach the new archers. We now have a field and a woods archery ranges and a coaching program for archery. The classes they have run to introduce new folks to archery have all filled up very quickly. This is a great addition to the many activities our chapter has to offer. Because of this David Goldberg is receiving the Chapter's Meritorious Service Award. Congratulations to both Mash and Dave. I am sure they will both continue to support the chapter for many more years and I hope that next year we have new folks that we want to honor for step up to the plate to make this Chapter even better.

Maryland Waterfowl Hunters Be Aware (Greg Talamini)

There has been a very large increase in snow geese in the Atlantic Flyway.

It's estimated at more than one million birds. Special Conservation Order Seasons can run into March or April. There may be a special permit required in some states. There are some confusing regulations for these seasons. As an example, Maryland requires the special permit for the conservation-order season but not the federal duck stamp; New York requires the federal duck stamp but not the special permit. Because these are special management seasons, mandatory reporting requirements are in place as well. Maryland waterfowlers must possess the printed receipt showing proof of purchase of the Maryland Migratory Game Bird Stamp while hunting migratory game birds; the stamp itself isn't enough. Proposed Bylaw change (rerun from September)

Old Section 5.

Any member whose dues have not been paid before the first day of January in any year shall lose the privileges to use any range at the chapter until the dues are paid and the new Range Access Card has been received by the member. The date on the check does not suffice as proof of payment and a right to use any range. You must have the new card in your possession and properly displayed to use any range.

New Section 5.

Any member whose dues have not been paid before the first day of January in any year shall no longer be a member in good standing and shall lose all Chapter privileges.

Old Section 6.

The Membership Secretary shall mail a second and final bill to members who have not paid by the second week of January advising them that they shall be deemed in arrears and not a member in good standing if payment is not received by February 1st. The member's right to purchase skeet and trap range cards or shooting and archery supplies, and all other membership privilege shall be suspended until the dues are paid. A late fee may be assessed to the dues payment as noted on the second bill. A list will be made on April 1st of all members who have not renewed and shall be conspicuously posted in the Chapter and Range Houses. You may choose to renew at any time before the end of the current year and have your privileges restored by paying your bill with any associated late fees.

New Section 6.

By the second week in January the Membership Secretary shall mail a second and final bill to members who have not paid by December 31. A late fee may be assessed to the dues as noted on the second bill. If payment is not received by February 1st, the member shall be dropped from the rolls and must re-apply for membership.

Then a lot of workers jumped to other crews to help out.

There was a crew who cleaned up the bedding around the chapter house; a rain garden crew; an elm tree nursery trail crew; and island in front of the shotgun house crew; and a Leyland Cyprus crew. And I can't forget our "Wandering Bub" who weed whacked about everything that could be whacked - including part of the Christmas tree lot.

The Leyland Cyprus group formed yet another crew who worked with me to load the staggering amount of cut brush on to our club trailer and unload it at our brush composting site in the back left corner of the trap and skeet impact field. In all James Borum, Dave Wrona, Henry Flanner, and Haytham Najjar loaded and unloaded 5 or 6 - 8' x 12' trailer loads of brush. Thanks for your hard work and double duty. (I hope you all remembered the Advil when you got home.)

Chuck and Barb Crooks carted 2 and one half skid of clay birds down to the trap and skeet houses using our Case 580 Super L, where boxes of clay birds were loaded into high and low houses. They finished up their day by using the Case to push all of the dumped brush deeper into the composting area to make room for future loads.

Everywhere I looked I saw members hard at work to improve the appearance of our chapter grounds.

Thanks to you all. Please don't be a stranger. Maintenance day happens once a month for three hours. I look forward to getting to know more of you by your first name.

WAC Range Safety Officer Committee, Rifle and Pistol (Jesse Lim/ Wendy Smith)

Important! It is your responsibility to read and understand our WAC R/P range's safety conduct and rules http://www.damascusiwla.org/RiflePistolRules.html

Although members should read and understand ALL R/P rules, we would like to highlight a section under CONDUCT that we need to ensure all members are aware of:

18. No member may use our ranges for commercial training purposes. Using any WAC firearms range for financial gain, personal or otherwise, jeopardizes our charitable organization status and is a major conduct violation of our range rules. Anyone found to be in violation of this rule will have his or her range privileges suspended pending investigation by the Rifle and Pistol Range Safety Officer Committee, which will present its findings to the Board of Directors for their action.

If at any time you are approached by anyone at WAC for individual training for a fee on our rifle or pistol ranges, have any questions about the R/P rules, concerns about member conduct on the R/P ranges, do not hesitate to contact Jesse Lim.

WORK ACTIVITY RECORDING

Probationary members have a work requirement. Most understand that. But, there is some confusion as to how that work requirement is fulfilled. New members must help with a minimum of two projects in each of their first two years of membership. Failure to do so will prevent a renewal of your membership the following year (you could be charged an additional registration fee in order to renew). When you work on a project you are required to be there for the entire project. You are expected to arrive on time for the project. If you leave early you will not get credit for the project.

In year one of your membership, you are required to work on a minimum of two projects. One of which must be a conservation based project. The second project can be any club project including another conservation event.

In year two, you are required to work on a minimum of two projects. One of which must be a conservation based project. The second project can be any club project including another conservation event.

You cannot work additional projects in year one and have them carried over to year two. The work requirement is set up to span two years with the hope that members will find projects they are interested in and want to support after they have completed their probation.

All projects will have a signup sheet. FIND IT. If you do not sign the sheet we do not mark you as there. It is your responsibility to sign in for proper credit. If you are a probationary member, be sure to check the box that says you are probationary, otherwise it will not be recorded.

Each monthly newsletter will show the credit given, by project, and who was there. Check to see if your name is listed. It is possible your name was not legible.

Mistakes can happen. When they do we want to correct them as soon as possible. Check the newsletter after volunteering and report any error as soon as possible. Our newsletters are archived back to 2005.
