This event is a lot of work. A full year of planning is required and it can all fall apart without our volunteers. Your service to the club is greatly appreciated. TVD is also one of our biggest and most successful, fundraising events.

This year was our 15th year of hosting the Maryland State Championship of Cowboy Action Shooting. We had 107 shooters including over a dozen of our chapter members. After the smoke had cleared, the Maryland State Champion is our own Mike Sage AKA Sagebrush Kid.

Cowboy Action Shooting is a shooting sport that uses single action revolvers, a lever action rifle and a shotgun to shoot various courses of fire, called stages. Shooters compete against each other in various categories. The object is to shoot the stage in the fastest time without any mistakes. Time penalties include 5 seconds for each missed target, 10 seconds for shooting the targets in the wrong sequence and 10 seconds will be added to your time, for a minor safety violation.

The event includes a day of side matches and two days for the 10 main stages. It all culminates with an awards banquet on Saturday night.

It all adds up to a lot of fun. Period clothing adds to the atmosphere representative of the late 1800's. If you would like to learn more about the sport, stop by one of our monthly matches (the 4th Saturday of the month, March thru November). Also watch your newsletter for our introduction to Cowboy Shooting Clinics held twice a year. UPCOMING CHAPTER CONSERVATION WORK EVENTS

Sunday August 24. Adopt A Road. Meet at the green maintenance shed at 8:30 a.m. Up to eight workers are needed for the Adopt A Road. Gloves, hand tools, water, and trash bags will be provided. Contact Meo Curtis (meosotis58@verizon.net) to let me know you are going to be there.

Saturday September 6. Native Tree Project Maintenance. 9 a.m. to Noon. This is an off-site work project. Gloves, tools, and water provided. We will remove invasives around previously planted trees and cage up volunteer trees to protect them from deer browse.. Student Service Learning credit if forms are brought on the day of the event. OTHER CONSERVATION NEWS JULY GARDENS MAINTENANCE:

We had an even dozen workers working on gardens maintenance. They valiantly pulled vines and other overgrowing weeds in the planter boxes of the Shotgun Shed, outside the Chapter House, and in the Butterfly Garden. They really went to town at the rain garden next to the Shotgun Shed, taking out our arch enemies of bush and vine honeysuckle and tree-of-heaven. Thanks to all for their very hard work.

As the Chapter membership has grown, I have met more and more members who really do know how to tell a desired plant from a weed. This has been very helpful when setting folks out around our grounds. If any member has ideas about plantings or removals around the Chapter and is willing to help organize to implement these ideas, please contact me at meosotis58@verizon.net or come to a Conservation Committee meeting (first Wednesday of the month at 6:30 p.m.)

NEEDED: Adopt-A-Road Coordinator. Help protect our local streams and the Patuxent Reservoirs from litter and associated pollutants by organizing our Chapter's Adopt-A-Road events. The Montgomery County Adopt A Road program requires that we clean up Mullnix Mill Road, requested for six times per year Right now, there are June and August Adopt-A-Road specific events and for the past many years, we have done both Mullinix Mill Road and Long Corner Road. We also include both of these roads in our spring and fall Watershed Clean ups which are open to the general public. I will continue to provide lead for coordination of the Watershed Clean ups but would welcome a co-coordinator who would be lead for organizing the Adopt-A-Road events.

The Chapter provides the bags, gloves, some litter grabbers, and water. The Adopt-A-Road Coordinator would be responsible for recruiting workers, acquiring supplies, organizing on the day of the event, requesting pick up by the County, and reporting to the DOT Adopt-A-Road program. WAC Range Safety Officer Committee, Rifle and Pistol (Jesse Lim) rerun

Important! Read and know ALL WAC R/P range's safety conduct and rules!

On May 18th, a WD40 aerosol can with residue still in it was found on the uncovered pistol range. Shooting at aerosol cans is prohibited. Please familiarize yourself with the following definitions in the Rifle and Pistol Rules -SAFETY SECTION:

- 10. Permissible targets include paper, balloons, and frangible, biodegradable items such as candy, crackers and clay pigeons. Such targets must be attached to the target backboard and mounted so they do not obscure the steel target stand frame.
- 11. Permissible free standing targets include, commercially made steel or "self-sealing" plastic targets which swing, spin, or fall when hit by a bullet.
 - A. Explosive targets (e.g., Tannerite) are strictly prohibited.

WORK ACTIVITY RECORDING

Probationary members have a work requirement. Most understand that. But, there is some confusion as to how that work requirement is fulfilled. New members must help with a minimum of two projects in each of their first two years of membership. Failure to do so will prevent a renewal of your membership the following year (you could be charged an additional registration fee in order to renew). When you work on a project you are required to be there for the entire project. You are expected to arrive on time for the project. If you leave early you will not get credit for the project.

In year one of your membership, you are required to work on a minimum of two projects. One of which must be a conservation based project. The second project can be any club project including another conservation event.

In year two, you are required to work on a minimum of two projects. One of which must be a conservation based project. The second project can be any club project including another conservation event.

You cannot work additional projects in year one and have them carried over to year two. The work requirement is set up to span two years with the hope that members will find projects they are interested in and want to support after they have completed their probation.

All projects will have a signup sheet. FIND IT. If you do not sign the sheet we do not mark you as there. It is your responsibility to sign in for proper credit. If you are a probationary member, be sure to check the box that says you are probationary, otherwise it will not be recorded.

Each monthly newsletter will show the credit given, by project, and who was there. Check to see if your name is listed. It is possible your name was not legible.

Mistakes can happen. When they do we want to correct them as soon as possible. Check the newsletter after volunteering and report any error as soon as possible. Our newsletters are archived back to 2005.
