# Be Prepared: 2019 Membership Renewal Process Starting Soon

The motto of the Boy Scouts of America "Be Prepared" comes to mind as the IWLA Wildlife Achievement Chapter begins the annual membership renewals process for calendar year 2019. You are asked to contact Membership Secretary Tim Garrity at <a href="membership@iwlawac.org">membership@iwlawac.org</a> right away if your contact information has changed within the past 12 months.

Membership renewal notices are expected to go out within a few weeks and it is vital your information is current. Email is the primary communications channel, so be sure to let Tim know if your address has changed or if you have additional addresses to include. To reduce postage costs, and minimize the use of paper and fossil fuels, invoices will be sent via email to the greatest extend possible. Paper-based renewal forms will be sent to those that do not have email accounts.

Here is what else you are asked to do to facilitate the renewals process:

- Add the email addresses <u>membership@iwlawac.org</u> and <u>IzaakWaltonWAC@iwlwac.org</u> to your list of safe (or approved) senders so related messages do not get filtered out as spam mail.
- When you receive your invoice, send a check or money order (payable to IWLA) for the full amount by the preferred November 1 due date to the address listed on the invoice. Partial payments will not be accepted and returned.

## **Complete Probationary Work Requirements**

Probationary members are urged to complete any remaining work requirements before the end year of each of the first two years of their membership. Two work projects must be performed each year and at least one of them each period must be of conservation nature. The chapter calendar includes a comprehensive list of activities along with a point of contact (POC) for each. You are urged to reach out to the POC to express your interest and be sure they still need support. Activities listed in green represent conservation work activities; those in brown are regular work projects.

Opportunities for conservation work credits diminish near the end of the calendar year so do not delay. If you unsure about your probationary membership status, please contact Nick Giuliano at <a href="mailto:nicolasgiu@yahoo.com">nicolasgiu@yahoo.com</a>. If you have any other questions or concerns about your membership contact Tim Garrity. If you do not plan to renew your membership, please let him know as soon as possible to reduce the associated administrative workload.

# **Probationary Work Requirements for Members with Limited Abilities**

All members, regardless of physical abilities, are required to complete two work projects per year for the first two years of their membership in order to fulfill the terms of their probation. Chapter leadership will provide opportunities for members to make a contribution during work projects that require physical labor (i.e., range maintenance). Tasks can be assigned that require minimal or no physical labor. Members with limited abilities should contact the POC for events they want to support to discuss the nature of the event and determine what work they can perform.

Members need to legibly complete the sign in sheet made available for each work project. Be sure to check the chapter newsletter in the following month to ensure you receive credit for your service. ## **Lifetime Membership Costs**

Your annual membership renewal payment covers your financial obligations to the Wildlife Achievement Chapter, the Maryland State Division and the IWLA National organization. Members are welcome to become life members at either of these three organizations or any combination of them. Becoming a life member of all three eliminates the future need to pay annual membership dues if you are only a member in our chapter.

If you belong to multiple chapters, a lifetime membership in the IWLA National organization and the MD Division can help you save significant amounts of money as you must pay those renewal dues annually for EACH chapter in which you have a membership. A lump sum payment is required as payment plans are not available. The costs for lifetime membership are as follows:

Wildlife Achievement Chapter lifetime membership

- \$900 for individual membership
- \$1,375 for family membership

National lifetime membership:

- \$1,250 for individual membership
- \$1,875 for family membership

Maryland State Division lifetime membership:

- \$100 for individual membership
- \$150 for family membership

Lifetime membership in all three organizations:

- \$2,250 for individual membership
- \$3,400 for family membership

## OTHER NEWS

#### **Pollinators**

At this year's National Convention in Fredericksburg, the general membership voted to advocate in support of managing transportation and utility ROWs for the benefit of native pollinators. Most folks know of the recent dramatic decreases in honeybees widely publicized because of the adverse impacts on the agricultural economy. There have also been declines in a number of native insect pollinators, such as Monarch butterflies, with the loss of food sources and habitat thought to be major contributing factors.

ROWs are typically managed to prevent woody (i.e. shrubs and trees) growth. These areas are ideal for planting native seed mixes. The adopted policy recommends the use of best management practices that promote native pollinator plants while keeping out invasive species with minimal herbicide use.

The League's Conservation Policies guide the work of League staff, chapters, and divisions in unified support for strategies and actions to assure 'the wise stewardship of the land and its resources.'

# **Recycling News**


You may have heard about local jurisdictions having problems with recyclables such as paper, cans and bottles due to changes in the commodities markets. Recent import restrictions imposed by China resulted in a dramatic decrease of prices for commodities (especially paper). For example, paper decreased from \$73/ton last year to \$0 today.

China had been receiving over 90% of the paper collected in Howard County; today it accepts none. But wait! This does not mean you should stop recycling! After leaving your house in Howard County, recyclables go to Waste Management Recycle America in Elkridge to be sorted. From there:

- Paper is shipped to paper mills to be made into anything from office paper to shoe boxes to cardboard shipping boxes.
- Metal Cans are sold to steel plants and can become all sorts of products, including cars.
- Aluminum cans and bottles are sent to smelters to be made into new cans, bottles and other aluminum products.
- Plastic bottles and tubs are sorted by type. The plastic is then sold to manufacturers to be made into new plastic products including clothing and packaging.

Howard County diverts about 30,000 tons per year of recyclables from being sent out of County (and out of State) to a landfill. Paper, bottles and cans are easily recyclable when they are clean, dry and empty. For windowed envelopes, just rip those plastic windows off and recycle the paper. In Howard County, paper and cardboard make up about 62% by weight of the recyclables collected each week. 11% of the items are residue that is 'trash' that can't be recycled, including items that have been 'wishcycled' i.e. the resident 'wishes' they would be recycled. Remember, when in doubt, leave it out!


