## Pigtail Tree Maintenance—Sunday October 14

This was the second of our twice-yearly visits at the Pigtail Recreation Area reforestation site. Seven chapter members and worked to cut back the vines and other vegetation in and on the protective cages around trees in the reforestation area. In addition to all the weeds, we found a Dekay's brown snake, chokeberry fruit, and yet-to-be-identified buckeyes. Jim Piateski had the most interesting discovery—a pile of monarch butterfly wings at the base of a cage. The tree in the cage had passed on but a beautiful fall-blooming aster was taking its place. And on that plant- a large, very pregnant female praying mantis. Apparently, the monarchs came for nectar from the asters and never left. ## Fall Watershed Clean Up—Sunday October 28

For the first time ever, we had to reschedule our Fall Watershed Clean Up due to weather. The rainy weekends continue into the fall! Thanks to all who came out to work, including Ranger Riley Schwengel and his volunteer crew from DNR and to Rich Fried and Jeff Deschamps for their help in driving around to drop work crews off and pick litter bags up. All participants got a water bottle with our Chapter logo and lunch at noon.

We picked up along our Adopt A Road stretch of Mullinix Mill Road and also Long Corner Road. We collected 23 contractor size bags of litter, along with 10 car tires, one hulking truck tire, and miscellaneous larger items. Ranger Schwengel took a half-truck load of dumped shingles back to DNR for disposal.

Most of the stuff in the bags was recyclable bottles and cans, but see below for a really gross find as reported by Scott Broom on Facebook.

A Note to our probationary members: When you come out to work a Chapter Maintenance day it means no matter how many Ranges you work on you get ONE regular credit for the day. A day usually means about three hours or so.

In the example above, we had only one Signup Sheet, which is normal, with the members designating the range or ranges they worked. No matter how many ranges the member works they get just one regular credit for the day. The only exception to this is as, with the Signup Sheet Above, we had members that listed that they had worked on Christmas Trees, some worked on Ranges and Trees. When we have a Signup Sheet with mixed activities, if any activity is conservation, the member gets a conservation credit for the day.

It can take several weeks to complete processing payments and restore access after payment is made.

It is hoped you will renew your membership and invite family and friends to join us.
