

### CHAPTER NEWS AND EVENTS

President's Corner August 2019

In July, the National IWLA convention was held in Des Moines Iowa. The theme of the convention was conservation and how individual IWLA chapters can help with educating and developing programs that support conservation efforts – in particular the Clean Water Act. I learned how single-use plastics affect our Oceans and marine life. I never give it a much thought before attending the conference about my personal use of plastic water bottles and plastic bags for my groceries. At home – I have plenty of reusable cloth grocery bags and lots of reusable water bottles. I need to use them!

Did you know a disposable plastic bag takes approximately 20 years – single-use plastic bottles can take up to 450 years - to break-down into microplastics? The majority of marine litter is plastic. As the plastic decomposes it omits chemicals and toxic particles – often clinging together creating "islands" floating in our oceans. Some plastic entangles marine life and some plastic is consumed. It is very common for Baleen whale species (filter feeder) to die from plastic. The whale's stomach acid cannot dissolve plastic. The consumed plastic creates hard plastic lumps in their stomach/intestines that can pierce the stomach/intestines. If the plastic doesn't pierce the digestive tract it will eventually starve the whale. Whales are NOT the only species to be threatened by single-use plastic. Sea Turtles will ingest plastic bags mistaken for a jellyfish (their natural diet) and suffocate. Birds – landing on the floating "islands" of plastic wrongly sees it as a food source. The plastic in the stomach gives a feeling of fullness – basically starving marine life to death.

Please think about what you can do to keep our waters clean and our marine life safe. WAC offers conservation opportunities that support The Clean Water Act. I challenge you to "Get Your Feet Wet & Clean Up A Stream." Get involved with our "Save Our Streams" and become a stream monitor. Join in and pick-up trash before it gets to our waterways by volunteering for our Adopt-A-Road monthly WAC event. Next Adopt-A-Road event is scheduled on Thursdays August 22<sup>nd</sup>. Join our Conservation Committee that meets the first Wednesday every month at 6:30 pm at the WAC Chapter House.

There is so much you can do as an individual – but even more as a group all united with a common purpose to "strive for the purity of water."
