
Patuxent River Trail Project—Conservation Work on March 1

In the November newsletter, there was an article about the Patuxent River Trail Project work days. On Sunday, March 1 from 9 a.m.-2 p.m., the Patuxent Spring 2020 Trailwork Series will begin, and the Chapter will be participating with conservation work credit for probationary members. There will be donuts and coffee beforehand and lunch afterwards. The trail work will be down the road, near where Mullinix Mill Road crosses the river, with parking at the Chapter and then we'll shuttle workers to the access site.

Work consists of clearing vegetation (including thorny stuff) and low tree limbs along the marked path and some initial smoothing of the natural surface path. All tools and gloves provided—expect to get dirty and dress appropriately. Student service learning hours available for students 12 years and older.

The total trail work is expected for about 25 miles from Long Corner Road to Georgia Avenue and take about five years of volunteer and contracted professional effort. Rodger Moran has volunteered to be the Chapter's liason for coordination, as needed, for future work days. To volunteer for the March 1 work day, contact rodger.j.moran@gmail.com.

Clean water is an essential part of the environment, making possible many outdoor recreation activities, including hunting, fishing and boating. At some point in their life cycle, streams form or contribute to habitat needed for the survival of many species.

Two years ago, our Wildlife Achievement Chapter revived stream monitoring and began collecting chemical, biological and physical data from a location on the nearby Upper Patuxent River. In 2019, an additional monitoring site was added in Lower Magruder Branch Park. Magruder Branch is part of the Potomac River watershed.

Monitors collect data using basic chemical testing techniques as well as noting physical conditions in and around the streams. Bi-annually, macroinvertebrates living in the stream are collected, identified and counted. The data is then entered into the Izaak Walton League's Clean Water Hub database. The data is also reported to Montgomery County Parks and Maryland Department of Natural Resources. Ideally the data can be used to advance local and regional environmental policy.

Meaningful data collection requires trained individuals to commit a few hours of their time every couple of months. Four people contributing eight hours a year each can monitor a site up to eight months a year.

However, monitoring does require a couple of hours of training. In 2020, we invite observers to watch and learn how our chapter monitors the Upper Patuxent site. If you are interested, choose a date posted under Save Our Streams in the chapter calendar and notify Stephen Meyer at stephen.meyer7@gmail.com. Please do not show up unannounced, as our site is only a couple of yards wide. Once training is completed, conservation credit can be awarded for any monitoring performed.

The Izaak Walton League of America (IWLA) is providing a workshop for those who wish to learn how to test their local water quality and become a certified SOS Monitor. Training materials will be supplied for attendees.

This training applies to Maryland monitors as well.

It's something we teach in every NRA Rifle and Pistol Class:

IT IS THE GUN OWNER'S RESPONSIBILITY TO ENSURE THAT UNAUTHORIZED OR UNTRAINED INDIVIDUALS CANNOT GAIN ACCESS TO HIS OR HER FIREARMS.

If every gun owner in America followed the advice of the NRA and State law we would see a lot less gun violence reported by the media. So please take inventory of your situation. What steps have you taken to prevent unlawful access to your firearms? If you can afford a firearm, you can afford to make it inaccessible to unauthorized people. Please make this a part of your New Year's Resolutions.

RANGE SAFETY (Chuck Crooks) (*This can't be posted enough*)

The club has had security cameras in place for about 6 years. The cameras became necessary after some property thefts and general safety concerns.

Range rules are established for a reason. They are designed to protect the safety of all members, their guests, our neighbors and our property. For these reasons, we take range violations very seriously. No matter how trivial you might think a rule is, there is a basis for safety that must be adhered to.

Recently there has been a series of range rule violations including; shooting from a holster at a non-sanctioned event, failure to display range cards for members and their guests, shooting from the hip, shooting beyond the posted hours, failure to wear safety glasses, failure to write a guests name on the sign in log, using rifle caliber firearms on the pistol ranges and having more than one firearm on the firing line at the same time.

Initial violations (handled by the rifle and pistol committee) can be a warning and/or suspension from the ranges until you retake the range safety course. Serious violations may be reviewed by the board of directors for disciplinary action, up to and including dismissal from the club.

As you know, firearm ranges are always on the radar, especially in our area. Therefore we take our rules and the safety of our members and guests a priority.

As range officers, you are asked to report known violations to the rifle and pistol chairman.
